BOOKING CONDITIONS

Please carefully read the following terms and conditions.

TRAVEL INSURANCE

You need to obtain comprehensive medical and travel insurance to participate on a tour. We will ask you to submit a copy of your insurance certificate before you travel.

PASSPORTS AND VISAS

You need to have a valid passport to travel internationally with at least six months' validity from the date of your return to Australia. If visas are required, we will let you know. While we will do our best to assist you to obtain visas, it is your responsibility to ensure that you have the correct visas before you travel.

CHANGES IN PRICE AND ITINERARY

We reserve the right to increase the price of the tour if there is a significant change in the exchange rates. In addition, occasionally there are circumstances beyond our control which require us to make changes to the itinerary and advertised hotels, airlines and tour leaders. We will let you know of such changes as soon as they arise.

DUTY OF CARE

While on tour to ensure your safety and care, and those of each tour participant, it is important that you follow reasonable instructions of the tour leaders.

DEPOSITS & FINAL PAYMENTS

You are required to pay a non-refundable deposit to secure your place on a tour and pay the balance 60 days before departure. We will send you an invoice for final payment about 75 days before departure. Deposits and final payments can be made by cash, cheque, direct credit. If you paying by Visa or MasterCard, a 1.5% surcharge applies.

CANCELLATIONS

If you wish to cancel your booking, you need to let us know in writing. The following cancellation charges will apply:

More than 60 days before departure	The deposit is forfeited
Between 60 and 45 days before departure	25% of the total tour cost
Between 44 and 22 days before departure	50% of the total tour cost
21 Days or less before departure	100% of the total tour cost

The cancellation date is the date we receive your written advice.

If we cancel a tour because of insufficient bookings, we will let you know about 75 days before departure and you will receive a full refund of all monies paid.

INCLUDED SERVICES NOT UTILISED

If you do not use the included services such as accommodation, meals, or entrance fees, we regret that no refund is available.
